Law for Palestine Organization

Judicial decrees, decisions, positions, and orders issued by Palestinians bodies:

- A member of the Executive Committee of the Palestine Liberation Organization Dr. Hanan Ashrawi has invited the international community **to implement effective steps in order to confront Israeli violations**. (April 27, 2020). click here
- On the occasion of Labor Day, the Palestinian National Council called for the **protection of Palestinian** workers from occupation crimes. (May 1, 2020). click here
- Taysir Khalid, a member of the Executive Committee of the Palestine Liberation Organization, said that the announcement made by the Prosecutor of the ICC to open an investigation in Palestine opens the way for Netanyahu and Gantz to be brought to the international justice (May 1, 2020). click here
